

2021 Jr. Miss Pana Tri-County Fair Pageant General Rules

1. Contestant must be a U.S. Citizen and have been a resident of Christian, Shelby, or Montgomery County, IL for 6 months prior to pageant date. Must be a resident date of pageant. Must not have won a County Crown, for age division.
2. Contestant must be 10-12 years of age by the pageant date.
3. Contestant agrees to be personally interviewed by the judges; judged on stage in sportswear/casual wear and formal wear.
4. Contestant must never have been convicted of a felony offence.
5. All the Contestants **MUST** sell **\$200** in 50/50 Tickets. There will be a 1st place top seller. Top seller are selected based on Money not Tickets. Also, if you sell \$300 in tickets you will get your Registration of \$25 refunded to you!
6. Contestants are required to attend the Interview and Final Rehearsal.
7. Hair & Make-up for this pageant must be age appropriate. Dress **MUST** have straps. **NO LONG GOWNS** and **NO MINI SKIRT STYLE!** End of your gown must come to your finger tips!
8. The newly selected JR MISS will serve as hostess for the week of Pana Tri-County Fair.
9. Prerequisites and duties of the newly selected JR MISS will be:
 - A. Jr. Miss will **NOT** partake of alcoholic beverages while representing Pana Tri-County Fair at any function.
 - B. It is strongly suggested that the JR MISS refrain from smoking, while Representing the Pana Tri-County.
10. Attendance at local parades and pageant are encouraged but not mandatory. You will be responsible for your own transportation and securing a vehicle for parades that you want to attend.
11. If the newly selected JR MISS cannot fulfill all of the expressed duties or violates any rule set forth for a candidate, she will relinquish her title, crown, and **ALL PRIZES** upon the direction of the Pageant Director. The first runner-up will then be eligible for the title.
12. Please keep pageant/fair drama (from contestant or parents/guardians) off social media. No bashing of any kind on any social media. If this becomes apparent the contestant will be disqualified; if new reign has already taken place then Rule # 11 will go into force. If you can't say something nice don't say anything at all!
13. JR MISS is **NOT** allowed to have social media **OF ANY KIND** (Facebook, Instagram, Twitter, Snapchat, etc.) We cannot express how important this is!
14. **HAVE FUN!!!!** This is what pageants are all about!!...In the end there is only 1 winner and **LOTS & LOTS** of **NEW FRIENDS!!!!** Please encourage good sportsmanship!
